Clear Channel Broadcasting, Inc. its subsidiaries and affiliated companies (together, the "Company"), will conduct the Contest substantially as described in these rules, and by participating, each participant agrees as follows:

1. Description of Contest/Participation.

- A. Dates of Contest: The Contest will begin April 24, 2009 and will conclude at 10AM on May 8, 2009.

NO PURCHASE NECESSARY. PURCHASE DOES NOT INCREASE ODDS OF WINNING. Void where prohibited. Odds of winning depend upon the number of eligible entrees at each location (as stipulated below), and the number of entrees and texts received the day of show (as stipulated below).

- B. How to Enter:

There are three (3) methods to enter the drawing for a brand new 2009 (DESCRIPTION) from GOT Toyota:

Method One (1):

Stop by Glendale or Tustin Toyota (the two GOT Toyota locations - Tustin Toyota 44 Auto Center Drive, Tustin, CA 92782 or Toyota of Glendale 1260 S. Brand Blvd., Glendale, CA 91204) before the entry deadline, fill out an official entry at the customer service desk and deposit it in the official entry box. One (1) qualifier will be drawn at random from entries received at each location (total of two (2) qualifiers). Each of these qualifiers will win a pair of tickets to KIIS FM's Wango Tango concert at Verizon Wireless Amphitheater on May 9, 2009, where the final drawing for the car will be held.

Method Two (2):

Or, Stop by the GOT Toyota display booth at KIIS FM's Wango Tango Concert at Verizon Wireless Amphitheater on May 9, 2009 before 6PM, fill out an official registration form and deposit it in the official entry box. At 6PM, a third qualifier will be drawn at random from the entries received by the deadline, and contacted at the cell phone number printed on the entry form. The person must answer their phone when called to accept the qualification status, or contest coordinators will have the right to move on. Names will be drawn randomly and called until a qualifier has been named.

Method Three (3):

Or, Watch the event jumbotron screens at KIIS FM's WANGO TANGO concert between 5:30PM and 6PM for the chance to TEXT in to qualify to win the car. Of everyone who texts in when prompted by the jumbotron message, a random texter will be chosen to receive upgraded seats for the show and be named the 4th and final qualifier for the new car from GOT Toyota. The texter must answer their phone when called by contest coordinators to receive the seat upgrade prize and be named the 4th qualifier. If a texter

does not answer when called, KIIS FM will choose another texter at random...and so on until a winner has been chosen.

C. Car Giveaway

Each of the 4 qualifiers (as described above) must be present at KIIS FM's Wango Tango Concert at Verizon Wireless Amihitheater on Saturday, May 9 between 6PM and 10 PM for the chance to win the car.

At some point during the show (time TBD), the four (4) qualifiers will be asked to go on stage between performances where the final random drawing will be held live.

Qualifiers will receive written instructions from KIIS FM relative to the exact report time and place to participate in the final drawing. If a qualifier does not report as directed, they will be disqualified from the final drawing.

2. Prize(s).

Two (2) pairs of tickets to KIIS FM's Wango Tango Concert will be given away in the random drawing held at each GOT Toyota location. Value of each pair of tickets is \$92.00.

One (1) pair of upgraded seats will be given away through in in-venue text promotion. Value of this pair of tickets is \$352.00.

One (1) - 2009 base model Prius from GOT Toyota. Value = \$22,000. The winner has the option of accepting a cash buy out of \$10,000 in lieu of accepting the vehicle.

3. Eligibility and Limitations. Participants and winner(s) must be legal U.S. residents, 18 years old, with a valid California Driver's License as determined by the Company at the time of winning, and reside in the Station's Total Survey Area (TSA). Entrants must have an active social security number, and be able to present the original social security card along with their California Driver's License to contest officials before accepting delivery of the prize. Only one (1) entry per person. Only one (1) prize per household from any of the Company's stations within any thirty (30) day period. Employees of the Company, GOT Toyota, Wango Tango participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

4. Telephone and Delivery Disclaimer. If a contest is a call in to win contest and/or a telephone is needed to participate in the Contest, participants are restricted to the use of ordinary telephone equipment.
